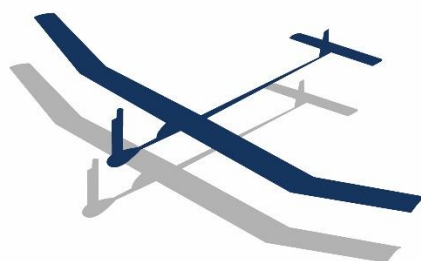

- **Organizer and venue of the competition**

The Czech Aviation Modellers Club in cooperation with the Aviation Modellers Club p.s. 418 Litoměřice, the Aviation Modellers Club p.s. 204 Roudnice nad Labem, the Institute of Technical Education Litoměřice, the city of Litoměřice, Roudnice nad Labem and the municipality of Raná.

Venue of the competition: flight area of Raná u Loun hill and surrounding areas. Raná is located in the northern part of the Czech Republic, near Loun.

Distance to Litoměřice: Prague 69 km, Brno 274 km, Ostrava 444 km, Rozvadov 230 km, Raná u Loun 34 km

The coordinates of the competition location are: GPS 50°24'25.5"N 13°46'45.0"E

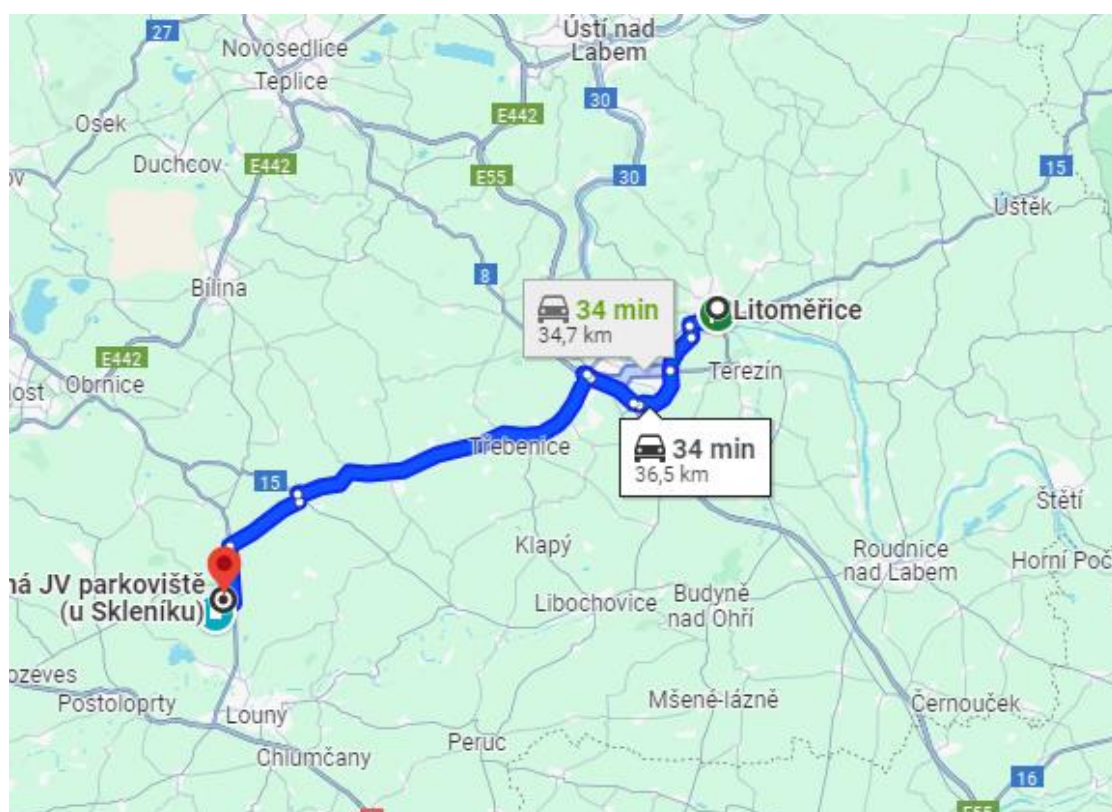
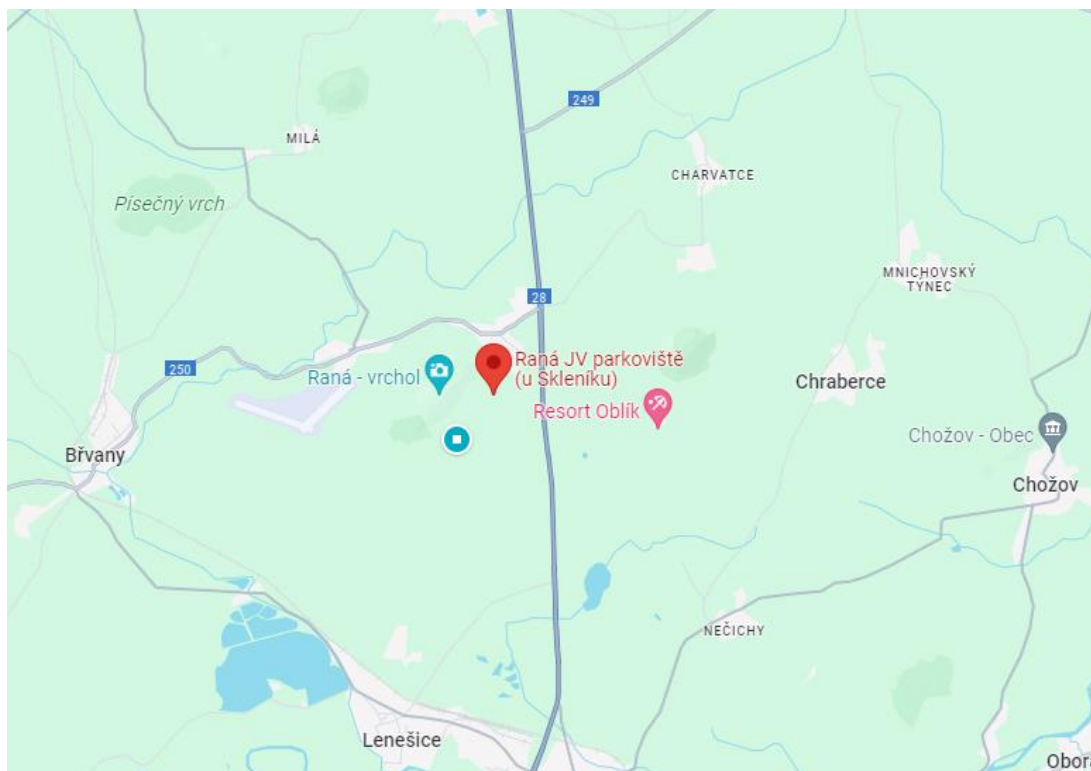
The flying site on the Raná hill is the Mecca of air sports with a history since 1932 in the field of gliding and motor flying. It is currently an important location for paragliding and model air sports.

The venue hosted the F1E World Cups in 2020, 2022, 2023, 2024 and the 2024 F1E European Championship.

The World Championship and two World Cup races will be held on the airfield on Raná Hill, where two opposing slopes are oriented southeast- southwest and southwest- north. The wind direction is favorable for the race in August on both slopes.

A reserve area is prepared near the village of Třtěno, on the Srna slope, where the F1E World Cup race took off on 24. 8. 2024

Expected weather conditions according to long-term statistics: partly cloudy to cloudy, sometimes showers or thunderstorms. Daily temperatures 27 to 31°C. Night temperatures 18 to 14°C. Wind S at a speed of 2 to 6 m/s.



The cities of Litoměřice and Roudnice nad Labem will host the F1E World Championship. The individual official parts of the Championship, such as the opening ceremony, closing ceremony, FAI medal ceremony and final banquet, will be organized by the individual host cities and organizational instructions will be specified in further bulletins.

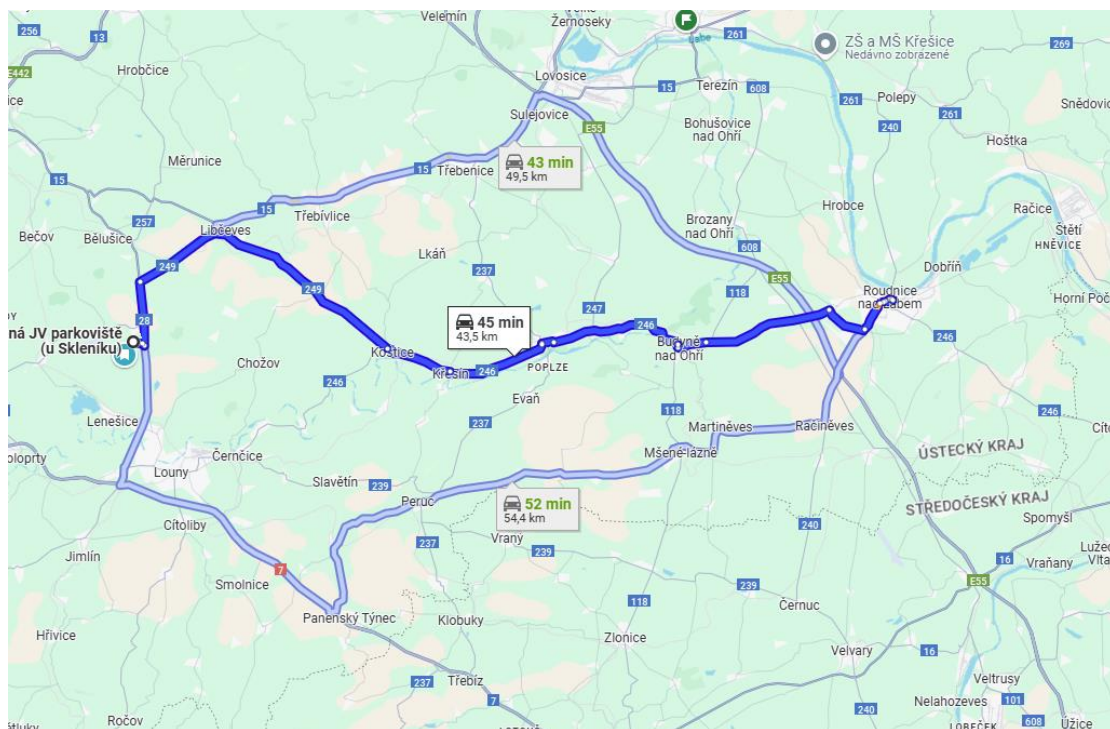

The championship will take place according to:

- FAI Sporting Regulations 2025 edition, CIAM General Rules and Volume F1.
- FAI General Section and FAI Code of Ethics.
- FAI Disciplinary Code.

Anti-doping statement

A competitor who needs for medical reasons to take any of the substances listed on the WADA Prohibited List must have a valid Therapeutic Use Exemption (TUE) signed by FAI.

To access the current WADA prohibited list of substances and additional information regarding the TUE, see the FAI website with the following link: <https://www.fai.org/page/anti-doping-therapeutic-exemptions>.

A quote from the FAI Anti-Doping Regulations: "If you regularly take a medication prescribed by your doctor and that drug is on the WADA Prohibited List, you must have your doctor fill out a form called a TUE (Therapeutic Exemption). Athletes at international level must send the form to the FAI Secretariat, athletes at national level must send it to their National Air Sports Control".

FAI Sports Licence: each competitor and team manager must hold an FAI Sports Licence valid for the Championship year. This license must be registered in the FAI license database.

Note: FAI sports license holders may be required to produce an official document with their photograph and signature as proof of identity.

- **IDENTIFICATION OF THE MODELS**

According to CIAM General Rules Volume C.11.1, each model aircraft shall carry:

- The national identification mark followed by the FAI Unique ID number with letters and numbers at least 25 mm high.
- A model identification code with letters and/or numbers at least 10 mm high, clearly visible and different for each nominated model aircraft of the competitor.

Note: A model aircraft must not carry a national identification mark, an FAI licence number or an FAI sticker which relates to any person other than the competitor.

MODEL AIRCRAFT SPECIFICATION CERTIFICATE AND STICKER

According to the CIAM General Rules Volume C.12, each NAC shall process every model and shall issue for each model aircraft the Model Aircraft Specification Certificate provided by the FAI. A sticker shall appear on each model aircraft.

Note: The Model Aircraft Specification Certificate and the design of FAI sticker may be downloaded from the 'DOCUMENTS' section of the CIAM website (<https://www.fai.org/ciam-documents>) by clicking on 'CIAM FORMS & OTHER DOCUMENTS' section, and then on 'Events'.

Model aircraft not properly processed by their NAC, with FAI certificate and sticker, must be processed by the organiser at a cost of 8 Euro for each model.

• COMPOSITION OF THE NATIONAL TEAM

Each FAI-CIAM Member National Aeroclub/National Federation may enter a team consisting of:

- team manager, assistant team manager
- older competitors: a maximum of 3 competitors or a maximum of 4 competitors if at least one competitor is a woman;
- juniors ("Born on or after January 1 2007"): maximum 3 competitors or maximum 4 competitors if at least one competitor is female;
- according to the FAI Sports Regulations, the reigning senior world champion
- according to the FAI Sporting Regulations, the reigning Junior World Champion (with reference to CIAM General Rule 2023; section C.5.1 and C.5.3. d);
- official helpers, supporters.

• CLASSIFICATION AND AWARDS

The classification for the senior and for the junior championships are as follows:-

Individual overall classification

FAI gold, silver and bronze medals and FAI diplomas will be awarded to the competitors placed first, second and third in the individual overall classification for the class concerned.

Individual Women classification

FAI gold, silver and bronze medals and FAI diplomas will be awarded to the first, second and third placed females subject to at least six females competing in the class concerned. If the number of competitors is less than six, then only FAI diplomas will be awarded. The best placed woman earns the title of Women World Champion subject at least six females from four different nations are competing.

NATIONAL TEAM CLASSIFICATION

FAI gold, silver and bronze medals and FAI diplomas will be awarded to the first, second and third placed national team for the class concerned.

A medal and a diploma will be awarded to the team manager and to all competitors of each national team concerned.

CIAM Perpetual Trophies

The Serbia-France Junior Team Trophy will be awarded to the winning junior team. This current holder of the trophy is Poland.

• PROTESTS:

The purpose of a complaint is to obtain a correction without the need to make a formal protest.

At any time during a championship, a team manager who is dissatisfied with any matter must first ask the Contest director or the appropriate official for assistance. Complaints may be made orally or in writing in English.

A complaint shall concern only one matter. In case of different matters, separate complaints must be made. A joint complaint may be made, should multiple complainants have the same position on the matter concerned.

It is recommended that a complaint is made before submitting a protest.

Complaints must be made as soon as possible after the occurrence giving rise to the complaint, and shall be dealt with expeditiously.

If dissatisfied by the decision, the complainant(s) concerned must inform the Contest Director as soon as possible of the intention to submit a protest.

All protests must be presented by the team manager(s) in writing in English to the Contest Director and must be accompanied by the deposit of a fee of 50 CHF (or equivalent amount for a different currency). In the case of a joint protest, every protesting team manager must pay the protest fee.

Note: *It is recommended to use the Contest Protest Form which may be downloaded from the 'DOCUMENTS' section of the CIAM website (<https://www.fai.org/ciam-documents>) by clicking on 'CIAM FORMS & OTHER DOCUMENTS' section, and then on 'World and Continental Championships'.*

A protest shall concern only one matter. In the case of different matters, separate protests must be made.

A protest against a decision of the judges or other contest officials or against an error or irregularity committed during the championship(s) by another competitor or team manager must be lodged as soon as the contest situation requires but not later than 60 minutes after the incident. The same person is not permitted to present two consecutive protests on the same incident.

The deposit for a protest is returned only if the protest is withdrawn prior to the beginning of the effective treatment of the protest or if the protest is upheld.

- **ENTRY FEES**

€400 for senior competitor,

€300 team manager, assistant team manager

€300 per junior competitor

€80 per supporter, helper

- **TERMS**

The preliminary application should be sent to the organizers no later than April 1, 2025.

The final application must be sent to the organizers by June 1, 2025 at the latest.

At the same time, the entry fees for the team manager, assistant team manager, seniors, junior competitors, helpers, supporters should be sent to the following bank account by July 1, 2025 at the latest.

Payments sent after May 31 are subject to a penalty:

1-15 July: 10 % fine

July 16 - August 1: 20 % fine

The sender is responsible for the bank commission.

- **MEALS AND ACCOMMODATION**

The organizer does not provide accommodation, but will present proposals for possible accommodation in the Litoměřice locality in bulletin No. 2.

Meals for competitors and members of the implementation team will be provided during the competition day /junior and seniors/ in the price of the entry fee, by catering at the race location. For other companions, refreshments will be provided for a fee.

Banquet

50 EURO/senior; 50 EURO/junior. Payment will be made in cash against a receipt or when paying the entry fee by bank transfer.

- **INSURANCE**

The organizer will provide third party insurance for all participants during the competition for accidents involving injury to others and damage to property according to the host country legislation. Participants are recommended to organise their own individual health and travel insurance before travelling.

- **VISA REQUIREMENTS**

For countries where Czech entry visas are requested, they can be obtained at Czech embassies/consulates. For more information, please contact the Czech Ministry of Foreign Affairs.

- **REGISTRATION OF NATIONAL TEAMS**

At registration, the team manager must present the FAI licence, updated entry form (if there are changes), national flag (1m x 1.5m), national anthem on memory card and payment order only in case of late payment. The place of registration will be specified in Bulletin No. 1.

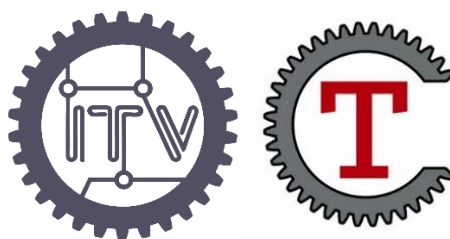
